In your opinion, what is the most important decision facing the district today? How would you address it?

This is an unsustainable situation long term. It is imperative that we partner with and listen to the needs of our educators as we proactively address teacher burnout and strive for increased teacher retention.

I feel strongly that right now, more than ever, our district and teachers need our support. I believe we support our students by supporting their teachers. The best way to support our teachers is to support their leaders. It is my promise that I will show up for all students, all staff, and all families.

Prosper is one of the fastest-growing districts in the state and nation. What is the best way to address that growth and how do we fund the needed buildings to accommodate students?

Part of the Prosper Promise, which I've been part of, is working together with parents, teachers, and district leaders to address problems and find effective solutions. As a trustee, I would work together with the six other board members along with district leaders to structure fiscally responsible bond programs that ensure our students have the buildings and facilities needed to continue high rates of success. We can continue to find the most effective ways to gain efficiencies with larger campuses, shared resources, and proactive long-range planning while maintaining strict standards of excellence.
